BUDGET WORKSHOP **September 16, 2019**

The Providence Township Board of Supervisors held a Budget Workshop in the Township Municipal Office on Monday, September 16, 2019 at 7:00 p.m. Present were Chairman John Schroeder, Vice Chairman C. William Shaffer, Member J. Pepper Goslin, Manager Vicki Eldridge, and seven (7) observers.

The meeting was called to order by Chairman Schroeder at 7:00 P.M followed by the Pledge of Allegiance and a moment of silence.

PUBLIC COMMENT

- Megan Bollinger, President of The Quarryville Library Board of Trustees provided additional library fund raising information and financial information to the supervisors.
- Dennis Blevins, Treasurer of The Quarryville Library Board of Trustees provided additional library financial information to the supervisors.
- Sylvia Drennen, the Director of the Quarryville Library explained the Pennsylvania Library Code as it relates to charging for library services.
- Dave Gerhart asked the library representatives what would happen to the library if they did not offer clubs and classes to the public. This would make the library completely an educational experience.
- Henry Esch thanked the board for paying an additional \$50,000 principal against the township mortgage.
- Lori Crossen encouraged the library to send mailings for donations to all residents, not just library patrons.

OLD BUSINESS

- Following discussion regarding the Route 272 project, Mr. Shaffer made a motion, seconded by Mr. Goslin to adopt Resolution No. 19-09 authorizing the Township Manager to sign and submit the Maintenance Agreement associated with the Route 272 construction project on behalf of Providence Township. The motion was carried unanimously.

NEW BUSINESS

- At this time, the proposed 2020 revenue projections were discussed.
- Mr. Shaffer asked the board to consider selling the township property behind Martin's Appliance. He doesn't feel it is wise to continue to pay taxes on a parcel of land that we do not intend to use.

ADJOURNMENT

- With no further business, Mr. Schroeder made a motion, seconded by Mr. Goslin, to adjourn the meeting at 8:57 p.m. The motion was carried unanimously.
