Chairman, Mr. Odell called the meeting to order at 7:00 p.m. Mrs. Minnick made a motion, seconded by Mrs. Kalupson to approve the minutes of the September 16, 2019 meeting. The motion was carried unanimously. The minutes were signed by all appropriate members present.

Mr. Odell introduced the first order of business, Dan Siegrist, Planning Module, 225 Mt. Hope School Road. Mr. Deimler explained the planning module.
