a.	Residential Structures - all floors included in square footage (including additions/accessory structures; excluding attics)	\$0.15/SF minimum \$50
b.	Commercial/Industrial Structures - all floors included in square footage	\$0.30/SF minimum \$150
c.	Agricultural Structures - all floors included in square footage	\$0.05/SF minimum \$30
d.	Projects not meeting the defined construction classification (pools/silos/manure pits/forestry)	\$.005 (1/2 cent) of total improvement costs; \$50 minimum
e.	Projects started prior to obtaining a permit	Double permit fee, maximum \$500.00
f.	Disaster Rebuilding-must be rebuilt as same footprint	Waived

a.	Application to Zoning Hearing Board	\$650.00
b.	Each additional request for the same property up to a maximum of \$850.00	\$100.00
c.	Continuance, requiring additional advertising	\$250.00
d.	Continuance requested by applicant or matter was continued for additional testimony, no additional advertising required	\$150.00
e.	Curative Amendment	\$2,500.00
f.	Petition to amend the zoning ordinance/map	\$750.00
g.	Challenges to zoning ordinance/map	\$750.00

4	Existing Driveway Paving Permit	\$20.00

a.	Single Test	\$200.00
b.	Each additional test on a single lot	\$100.00

17	Local Agency Law Appeal and Hearing	\$500.00 plus 1/2 of the court reporter fee
