SUPERVISORS MEETING March 3, 2025

The regular meeting of the Providence Township Board of Supervisors was held in the Township Municipal Office on Monday, March 3, 2025, at 7:00 p.m. Present were Chairman John Schroeder, Vice Chairman Lori L. Crossen, Member J. Pepper Goslin, Solicitor Melvin Newcomer, Township Manager Vicki Eldridge and seventeen (17) observers.

The meeting was called to order by Mr. Schroeder at 7:00 P.M. Chairman Schroeder offered prayer which was followed by the Pledge of Allegiance.

Mr. Schroeder explained that each Supervisor received a copy of the written minutes from the February 3, 2025, supervisors' meeting as presented. With no additions or corrections to the minutes, Mr. Schroeder made a motion, seconded by Mr. Goslin, to approve the minutes. The motion was carried unanimously.
