# SUPERVISORS MEETING July 7, 2025

The regular meeting of the Providence Township Board of Supervisors was held in the Township Municipal Office on Monday, July 7, 2025, at 7:00 p.m. Present were Chairman John Schroeder, Vice Chairman Lori L. Crossen, Solicitor Melvin Newcomer, Township Manager Vicki Eldridge and eleven (11) observers. J. Pepper Goslin was not in attendance.

The meeting was called to order by Mr. Schroeder at 7:00 P.M. Chairman Schroeder offered prayer which was followed by the Pledge of Allegiance.

#### **EXECUTIVE SESSION**

• Mr. Schroeder announced the Board of Supervisors held an Executive Session on Monday, June 23, 2025 at 6:00 p.m. to discuss a personnel matter.

#### **BID AWARD**

• Mr. Schroeder made a motion, seconded by Mrs. Crossen to award the Radcliff Road Bridge Removal Project to the lowest bidder, Flyway Excavating in the amount of \$99,500.00. The motion carried unanimously.

Mr. Schroeder explained that each Supervisor received a copy of the written minutes from the June 2, 2025, supervisors' meeting as presented. With no additions or corrections to the minutes, Mr. Schroeder made a motion, seconded by Mrs. Crossen, to approve the minutes. The motion was carried unanimously.

#### FINANCIAL REPORT

- Vicki Eldridge read the financial report.
- Mr. Schroeder made a motion, seconded by Mrs. Crossen, to ratify the payment of the June bills in the amount of \$110,385.15 from the general fund. The motion was carried unanimously.

#### **REVIEW OF BUDGET**

• There were no other comments at this time.

#### **PUBLIC COMMENT**

- Daniel Glick had questions about building a pedestrian bridge over the Pequea Creek.
- Edward Raczka asked the supervisors for permission to locate electric bike rental stations at East State Street and Fairview 1 Trailheads. Following discussion, the supervisors asked to revisit this subject at the August meeting.

# **ROADMASTER REPORT**

Jim Grube, Roadmaster, reported that during the month of June, the road crew worked on the following:

- Cleaning gutters on various roads
- Sprayed trail edges and benches, also guide rail and curbs on various roads
- Chipped trees down on trail
- Boom mowing on roads
- Two after hours trees on roads
- Repaired sinkhole on Smithville Road
- Attended PA 1-Call Safety Day in York
- Installed new tank in office toilet

- Possible Sealcoating of roads (contracted work)
- Prepare for Archery Road scour repair
- Safety meeting on Hazards of Floods
- Use millings from previous project on Archery Road and trail entrance at Sawmill Road
- Continue road bank mowing

# PARKS/RECREATION REPORT

- The parks and recreation committee meeting will meet on July 10, 2025 at 7:00 p.m.
- The Quarryville Police conducted 21 premise security checks encompassing an estimated 13 hours of coverage, with one notable event.
- Following discussion regarding the Quarryville Connector remaining grants funds. The supervisors are in favor of paving the entrance to the Groff Trailhead, adding a handicapped parking space and paving the trail between the Lime Street Connector and Eden Township.
- Following discussion regarding names for the Mountain Bike Park, Mr. Schroeder would like to see Providence Township in the name. Mrs. Crossen said she will reach out to the volunteers to discuss the trail name at the next meeting.
- Following discussion regarding accepting a donation to install park benches at the Quarryville Connector from an individual that volunteers for "Cycling Without Age", the board expressed interest. Cycling Without Age is an organization that utilizes volunteer cyclists to take those with physical limitations on bike rides.
